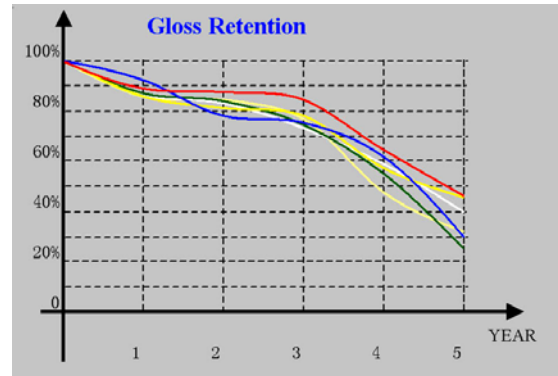
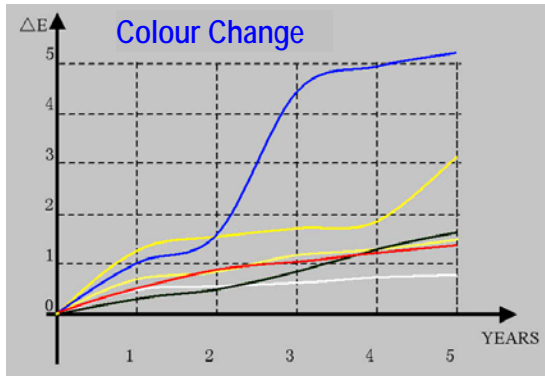

The above-mentioned guarantee is subject to the following conditions:

1. Aluminium Composite Panel is to be installed in normal climate conditions, which is exclusive of high polluted area having a temperature over 60°C, high salt or radiation.
2. Application, installation and maintenance of Aluminium Composite Panel shall be conducted according to the correct installation means, any contrived damage, error process and installation and abuse of chemicals are not included in the guarantee.
3. Aluminium Composite Panel shall be handled according to

regular method, and be stored in conventional, pollution and radiation free environment, deformation, wear and paint damage of the panel caused by improper handling or storage are not included in the guarantee.

4. Damages incurred by outside force / force majeure, e.g. fire, explosion, frictional impact and all accidents, natural disasters and contrived malicious damages etc., are not included in the guarantee.

5. Upon receipt of Aluminium Composite Panel supplied by our company, the customer shall immediately check the panel if abnormal conditions are found, then the defect, if any, shall be submitted to our company within 3 days after receipt of the goods.

Concealed defects, which can only be found during pulling off the protection film, shall be submitted immediately upon discovery,

Other potential defects must be submitted immediately if found within the period of guarantee.

6. If the customer finds during the period of guarantee that the quality of Aluminium Composite Panel does not meet the

guarantee standard, we shall compensate by way of replacement or renewal at our cost. If the customer declines to be compensated as per this method then we will reimburse the original cost.

7. Application of compensation by the customer must be authentic and fair, and compensation is only limited to the product quality, and will be inspected by the national quality supervision authority or a mutually agreed fair third quality supervision authority).

8. If a quality problem is found the customer must inform us in written form. We reserve the right to send our representative to the site and no action will be allowed by the customer until we have inspected the problem. We undertake to do this within three weeks.
